PRIVACY POLICY

The Pathogen Death Wand Company LLC whose registered address is 47 Marylebone Lane, London, England W1U 2NT (the "Company") is committed to maintaining robust privacy protections for its users. Our Privacy Policy ("Privacy Policy") is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our Service.

For purposes of this Agreement, "Site" refers to the Company's website, which can be accessed at www.pathogendeathwand.com and www.pdwand.com. "Service" refers to the Company's services accessed via the Site, in which users can input their personal data in exchange for information or to make a sales enquiry. The terms "we," "us," and "our" refer to the Company. "You" refers to you, as a user of our Site or our Service. "Distributors" refers to our approved Distributors as listed on the Company's website.

Your personal data refers to all information that may be used to personally identify you, such as your name, position title, company affiliation, phone number, email address or postal address.

I. INFORMATION WE COLLECT

We collect "Non-Personal Information" and "Personal Information." **Non-Personal Information** includes information that cannot be used to personally identify you, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. **Personal Information** includes your email, which you submit to us through the registration process at the Site.

1. Information collected via Technology

In an effort to improve the quality of the Service, we track information provided to us by your browser or by our software application when you view or use the Service through products such as Google Analytics. For example the data collected includes the website you came from (known as the "referring URL"), the type of browser you use, the device from which you connected to the Service, the time and date of access, and other information that does not personally identify you. We track this information using cookies, or small text files which include an anonymous unique identifier. Cookies are sent to a user's browser from our servers and are stored on the user's computer hard drive. Sending a cookie to a user's browser enables us to collect Non-Personal information about that user and keep a record of the user's preferences when utilizing our services; the statistics we collect are anonymous and aggregate.

The Company may use both persistent and session cookies. Persistent cookies remain on your computer after you close your session and until you delete them, while session cookies expire when you close your browser.

2. *Information you provide us*

In general you can browse our website without providing your personal data. Areas of our website may request you to input your personal data in exchange for information, such as a blog or case study. You can also use our contact page to input your personal data to make a sales or product enquiry. The data you provide enters an email account which is monitored only by representatives of the Company. Your enquiry will be assessed and if deemed appropriate we will provide your information to one of our Distributors. By entering your personal data, you are authorizing us to collect, store and use your Personal Information in accordance with this Privacy Policy.

II. HOW WE USE AND SHARE INFORMATION

1. Personal Information:

Except as otherwise stated in this Privacy Policy, we do not sell, trade, rent or otherwise share for marketing purposes your Personal Information with third parties without your consent. We do share Personal Information with vendors who are performing services for the Company, such as Distributors. We endeavour to carry out regular checks to ensure the companies we work with are GDPR compliant. Those vendors use your Personal Information only at our direction and in accordance with our Privacy Policy. In general, the Personal Information you provide to us is used to help us communicate with you. For example, we use Personal Information to contact users in response to questions, solicit feedback from users, provide technical support, and inform users about promotional offers. We may share Personal Information with outside parties if we have a good-faith belief that access, use, preservation or disclosure of the information is reasonably necessary to meet any applicable legal process or enforceable governmental request; to enforce applicable Terms of Service, including investigation of potential violations; address fraud, security or technical concerns; or to protect against harm to the rights, property, or safety of our users or the public as required or permitted by law.

2. Non-Personal Information:

In general, we use Non-Personal Information to help us improve the Service and customize the user experience. We also aggregate Non-Personal Information in order to track trends and analyze use patterns on the Site. This Privacy Policy does not limit in any way our use or disclosure of Non-Personal Information and we reserve the right to use and disclose such Non-Personal Information to our partners, advertisers and other third parties at our discretion. If our information practices change at any time in the future, we will post the policy changes to the Site so that you may opt out of the new information practices. We suggest that you check the Site periodically if you are concerned about how your information is used.

III. HOW WE PROTECT INFORMATION

We implement security measures designed to protect your information from unauthorized access, by implementing technological security measures including encryption, firewalls and secure socket layer technology. However, these measures do not guarantee that your information will not be accessed, disclosed, altered or destroyed by breach of such firewalls and

secure server software. By using our Service, you acknowledge that you understand and agree to assume these risks.

IV. YOUR RIGHTS REGARDING THE USE OF YOUR PERSONAL INFORMATION

You have the right at any time to prevent us from contacting you for marketing purposes or to unsubscribe from our communication lists or our blog.
